## **Coronavirus Emergency Measures Act – Proposed Extension**

### **A plea from your constituents**

Dear xxxxxxxxx

The proposal to extend the Emergency Measures Act for a further period is shortly to be put before Members of Parliament for a vote.

You will know that, if this extension is granted, it will inevitably lead to the government authorising mRNA vaccination of children between the ages of 12 to 15 initially; and in due course for younger children still.

The JCVI has said mRNA vaccinations are not safe for healthy children and the Yellow Card scheme (introduced following the thalidomide disaster) has already documented over 1600 deaths following mRNA vaccinations as well as over 1 million adverse reactions in the UK alone. **We therefore implore you to consult your conscience, consider what is best for your constituent's children and grandchildren and vote against this further extension.**

However, should you ignore our plea and vote in support of the extension and, as a reasonably foreseeable consequence, the mRNA vaccination of children goes ahead, then by this letter, you will not be able to declare ignorance of the following facts:

1. Your attention has been drawn to the numerous adverse reactions to mRNA vaccinations on the government's Yellow Card reporting scheme
2. You are aware of the JCVI advice that mRNA vaccination is not recommended for healthy children.
3. The government's health advisor is on record as having said that the risk of a healthy child dying or being injured by Covid 19 is negligible.
4. Government ministers have publicly declared their support for authorising mRNA vaccination of children of all ages.

5. The pharmaceutical companies have indemnity against any claim for damages; and so any harm to children will be a Civil Claim against those responsible for authorising it i.e. Members of Parliament

**6. Voting against the extension will prevent mRNA vaccination of children from being a possibility.**

Therefore, take notice that should you vote in support of this extension and it passes, you will have been jointly and severally responsible for mRNA vaccination of healthy children; and should any harm come to any otherwise healthy child, as a direct result of mRNA vaccination, you and the other MPs who voted for the extension will be held PERSONALLY & CRIMINALLY responsible.

Please be aware that we will provide financial assistance to the parents and/or grandparents of any child damaged by mRNA vaccinations in a CLASS ACTION at both UK level and additionally as an international crime against humanity.

Saying you were 'just obeying orders' or 'following the government line' will not be an excuse, given the Nuremburg precedent.

The Courts will be asked to seize the property, savings and belongings and confiscate the pension funds from MPs who supported the extension, in order to provide some financial aid to the parents and grandparents (your constituents) who will end up with the responsibility of lifetime care for their damaged children.

Whether adults wish to have the mRNA vaccine and boosters is up to them.

**We hope you will vote against the extension to safeguard our children and grandchildren.**
